Welcome to Idlewild & SoakZone. We are thrilled that you have made the decision to visit the park and our goal is to make your visit as fun and memorable as we possibly can. We are committed to providing the finest family fun and entertainment. This Safety and Accessibility guide will serve as an important tool to assist in planning your day at the park. Our staff is available to assist with any questions you may have with regards to accessibility at our Guest Services building or alternatively you may speak to any staff member, and they should be able to assist you.

Whether it's watching your child conquer their first ride on the Rollo Coaster, venturing together through Story Book Forest or splashing in the Wowabunga Wave Pool, Idlewild & SoakZone is a place full of smiles and long-lasting memories for guests of all ages and abilities. Founded in 1878, Idlewild is the third-longest operating amusement park in the United States. It has been recognized as "Best Kids' Park in the World" by Amusement Today, and "Best Park for Families" by the National Amusement Park Historical Association. The park features classic amusement rides, a water park, live entertainment, costume characters, and unique attractions such as Story Book Forest and Daniel Tiger's Neighborhood, all within the beautiful Pennsylvania Laurel Highlands.

### **General Park Information**

### **Mobility Devices and Rentals**

Idlewild & SoakZone is committed to providing a safe and enjoyable experience for all of our guests. Idlewild & SoakZone is home to a wonderful yet sometimes unpredictable and hilly terrain. Because of our terrain, coupled with the potential for crowded spaces that include small children and strollers, we regret that we cannot permit the operation of golf carts, multi-seat ECVs, bicycles, tricycle-style child carts, or two-wheeled self-balancing electric vehicles such as Segways by guests visiting the park.

Personal ECVs must be single-rider and may not have attached trailers or passenger carriers. Idlewild & SoakZone reserves the right to deny entry to any mobility device deemed unsafe for use in the park. Manually powered wheelchairs as well as a limited number of ECVs are available for rental on a first come, first served basis at Guest Services in Hootin' Holler.

Most areas of the park are accessible to mobility devices, however there are some locations of Story Book Forest that are not paved and may be difficult to navigate. Most attractions in the park have an alternative entrance that is accessible to guests using mobility devices. Most attractions do require that riders transfer to the appropriate vehicle to be able to experience the attraction. All show venues will have designated areas for guests with mobility devices to watch. All food and beverage, retail, and games outlets are accessible to guests in mobility devices.

The following attractions do not have an alternative entrance due to the presence of stairs in the attraction or queue:

- Confusion Hill
- Hydro Racers (SoakZone)
- Pipeline Plunge (SoakZone)
- Serpentine Slides (SoakZone)

The following rides allow a guest that cannot transfer from their mobility device easily, to experience the ride while remaining in their mobility device:

- Daniel Tiger's Neighborhood
- Loyalhanna Limited Railroad

Due to the nature of many of the standard queues having tight turns, it is recommended that guests using a mobility device stop at guest services to receive a Ride Admissions Pass so that they can use alternative entrances for attractions. The Ride Admission Pass will be discussed later in this document.

### **Service Animals**

Trained service animals are welcome at Idlewild & SoakZone. Under the ADA, service animals are limited to dogs and miniature horses individually trained to perform tasks for the benefit of an individual with a disability. Comfort animals, emotional support animals, or therapy animals

are not service animals according to the ADA regulations and these animals are not permitted in the park.

Service animals must remain on a harness or leash no longer than four feet, always remain under the control of their handler, and be house broken. If at any time a service animal's behavior is out of control, the guest will be asked to remove the animal from the park. Owners are responsible for cleaning and disposing of animal waste. Due to the nature of required ride restraints, service animals are only permitted to participate in the following attractions:

- Story Book Forest Walk-Through
- Confusion Hill
- Merry-Go-Round
  - o In designated areas of the chariots only
- Loyalhanna Limited Railroad
- Daniel Tiger's Neighborhood
- All Show Venues

Services animals are not permitted to participate in our water attractions in the SoakZone. While the service animal is waiting for their handler to participate in any attraction, a guest from the rider's party must remain with them outside of the operating area of the attraction. Idlewild team members cannot be responsible for watching a service animal and service animals may not be left unattended without a handler under any circumstance. The park does not provide kennels at any location.

There is a designated service animal relief area in the park located next to the bridge that connects Olde Idlewild with Raccoon Lagoon.

### **Guest Services**

Guest Services is located in the Hootin' Holler section of the park attached to the back of the General Store. Guest Services will assist with the following services regarding accessibility:

- Obtaining a physical copy of the Safety & Accessibility Guide
- Enrolling for a Ride Admission Pass and determining ride eligibility
- Enrolling for a Boarding Pass for alternative entry for guests with impairments that may prevent them from waiting in a standard queue
- Renting mobility devices
- Receiving information about any other accessibility related services we have in the park

There is a private area available at Guest Services for nursing mothers with access to electrical outlets for pumping.

### First Aid

Idlewild & SoakZone's First Aid station is located behind the Flying Aces ride in Olde Idlewild just before the entrance to the SoakZone. If you need immediate First Aid assistance, ask any park employee for assistance. Our team members have access to telephones and park radios to

bring a mobile First Aid unit to you in the event that you are unable to leave your current location.

Please note that the park does not provide medication, insulin, or other treatments other than basic first aid. Please plan your visit accordingly. Private areas are available at First Aid for nursing mothers with access to electrical outlets for pumping.

### Restrooms

The park has several restroom locations:

- Between Jumpin' Jungle and Loggin Toboggan
- Across from The Spider ride in Olde Idlewild (Family Restrooms Available)
- Raccoon Lagoon near the Loyalhanna Limited Railroad Station,
- Next to the Wild Mouse Exit on the path to SoakZone
- Center of SoakZone (Family Restrooms Available)

All restrooms include infant changing stations. Accessible stalls are located in all restrooms.

### **Quiet Areas**

With parking and picnic areas accessible from anywhere in the park, we make it easy to make a quick escape to a quiet space anytime you need. Throughout the day you may come and go from your vehicle as often as you need to store or retrieve items or just to sit in a quiet, familiar space for a few minutes to calm down. On your way from the amusement area to your vehicle you will pass through rustic picnic areas with pavilions and picnic tables that families may also use to escape for a quiet break. These areas are often quite secluded from other guests.

### Food and Beverage

Guests are permitted to bring their own picnic basket into the park. You may enjoy your picnic lunch in one of our scenic picnic groves. Pavilions that are reserved for group events will be marked with a "RESERVED" sign. Any pavilion that is not reserved is open to the general public. You may claim picnic tables for use for your group, but please be courteous and share the pavilion with other parties. Grilling is not permitted under a pavilion. All grills must be placed outside of the pavilion canopy.

Picnic baskets/coolers are permitted at SoakZone, but absolutely no glass items or grills are permitted within SoakZone. Guests with food allergy concerns may request information about product ingredients at individual outlets. Our team members are trained at handling allergens and while we take every precaution to ensure safe service to our guests with food sensitivities, we cannot guarantee that allergens are not present at specific locations within the park.

Because you know your sensitivities better than anyone else, we ask that you make an educated decision regarding what you are comfortable enjoying during your visit. If you have any questions or concerns, we ask that you speak with a Food and Beverage Supervisor or Manager either at a service location or at Guest Services.

### **Personal Care Assistant**

The cost of admission to Idlewild & SoakZone will be waived for a government-funded or privately paid Personal Care Assistant (PCA) whose attendance is required to enable a guest with severe disabilities to enjoy a day visiting the park. Whether the tickets are purchased in advance or at the gate for the guest requiring a PCA, any request to waive admission for the PCA must be made at the Main Gate Office, located just before guests surrender their tickets and proceed into the park through the admissions gates. The PCA shall not participate in any services/attractions separate from the individual who requires their services. If the park discovers that the PCA or guest has misrepresented the purpose of the PCA's attendance, both the PCA and the guest will be asked to leave.

### Oxygen Tanks / Concentrators

Due to the dynamic nature of our attractions, oxygen tanks are not permitted on most of our attractions. Guests are permitted to ride the following attractions with an oxygen tank:

- Loyalhanna Limited Railroad
- Daniel Tiger's Neighborhood
- Merry-Go-Round

Oxygen concentrators are smaller and are allowed on attractions if they do not interfere with the attraction's safety restraints.

### Lost Children/Parents

If a child or disabled individual becomes separated from your group, please stop any Security Officer, or go to Guest Services or First Aid. Please tell a staff member about the missing person and if they have special needs. It is important that you remain with the team member until the lost individual is located.

### Tips for planning ahead:

- 1) If your child is nonverbal or too young to remember a contact phone number or name, write this information on their wristband before you leave your car at the start of your visit.
- 2) Take a family or group photo with your phone before you enter the park so that you can easily remember what everyone is wearing and provide our team with a complete description of the missing individual.
- 3) Pick a favorite spot that everyone should return to if you become separated. Remind everyone of the plan as you leave your vehicle, and a few other times throughout the day so that information sticks with them.
- 4) Be sure to point out team members whose shirts have the Idlewild & SoakZone logo and Idlewild Security Officers to small children in your group. Let them know that these are the people to go to right away if they cannot find you.

If parties become separated and unable to contact each other, team members will direct guests to Guest Services as a meet up point.

### **Rider Swap**

Rider swap allows for members of a party to wait with a non-rider (guest or service animal) and then not have to wait in line separately once the rest of their group has ridden. There are two (2) options based on how your group would like to proceed throughout your day:

- 1) All members of your group can wait in the queue together. When you reach the boarding station, any non-riders will be directed to wait at the exit with an accompanying companion. When the first part of the group exits the ride, the guest that had not ridden yet will be given the opportunity to ride (they may be able to ride with someone from the first group so that they do not have to ride alone)
- 2) The same process will be followed as above; however, the non-riding group does not have to wait in the queue, they can partake in another activity and only needs to go to the accessibility entrance / ride exit when the rest of their group is exiting. This is the preferred method of conducting a rider swap so that a non-riding guest does not get upset about not being able to experience an attraction after waiting in line.

Guests should make the staff at the individual attraction aware that they will be taking part in a rider swap when they are being grouped at the attraction.

### **Loose Articles**

Many of our attractions have a no loose articles policy and will have a storage location for these types of items. Small tight to the body cross-body bags and fanny packs will be allowed on all dry-park attractions if the item does not interfere with the restraint system. Larger bags and other items that cannot fit securely into a pocket will need to be left in the storage area or with a non-rider. Idlewild is not responsible for any lost, stolen, or damaged items.

No loose articles will be permitted on any SoakZone attraction. Guests must wear proper swimwear to be able to experience our SoakZone attractions. Lockers are available to rent in the SoakZone area for loose article storage.

### Photography / Filming

On-ride filming and photography are not permitted on most attractions without written permission from the Attractions Manager, Director of Marketing, Director of Operations, or the park's General Manager. Any approved filming on these rides will need to be done using equipment that has been checked to ensure it is safe. For filming requests, please contact the park before your visit. Please contact the park at (724) 238-3666 with inquiries in this area.

Photography/Filming is allowed and encouraged in/on the following attractions by all guests:

- Story Book Forest
- Jumpin' Jungle (excluding Bigfoot's Mudslide)
- Confusion Hill
- Loyalhanna Limited Railroad
- Merry-Go-Round
- Daniel Tiger's Neighborhood

### Cellphones and Handheld items

All handheld items must be stored in a secured pocket on rides where photography is not allowed. These items may not be taken out during a ride. Use of cell phones or recording devices on attractions where it is not permitted can cause an operator to stop a ride early and may lead to ejection from the park without refund. Items cannot be held in a rider's hand during any ride that requires the guest to be able to hold on or brace.

### Lost Items

We ask that all riders secure items that could fall from the ride. Our rides travel at speeds and have forces that can cause items to fall out of pockets and cause riders to lose headwear. Please follow the instructions of our rides team members and secure items appropriately. If an item is dropped on a ride, notify our rides team member. The park will not stop operation of a ride to retrieve an item unless the item is critical in a guest's ability to experience the rest of their day. This decision will have to be made by a rides or aquatics supervisor. Most items will be retrieved at the end of the operating day.

All retrieved articles in the park will be brought to guest services. Found, valuable items (wallets, phones, keys, etc.) will be brought to guest services as soon as possible. Limited value items (glasses, hats, etc.) will be brought up at the earliest convenient time. If you have lost an item, check at the location you last had it first, and then check with the Guest Services team.

### **Smoking Areas**

Idlewild and SoakZone is a family environment to be enjoyed by all. Therefore, we have made efforts to accommodate both smokers and non-smokers. As a courtesy to our guests and for safety reasons, we ask that smokers refrain from smoking and vaping in all areas of the park except for parking lots outside the main park grounds.

Additionally, smoking and vaping are prohibited in all queue lines, on all rides and attractions, inside pavilions and at all restaurant seating and theater locations. Park staff reserves the right to ask any guest to extinguish cigarettes/cigars/pipes/vape pens immediately if they are not in a designated smoking area, and management may also ask any guest to leave, without refund, for continued non-compliance.

### Ride Admission Program (Determining Attractions Eligibility)

Our Ride Admission Program is designed with your safety and the safety of others in mind. Our staff at Guest Services will assess each Guest seeking accommodations based on their individual abilities, ride dynamics, ride restraint systems, and manufacturer requirements to determine what rides they can safely enjoy. You will be given a ride accessibility questionnaire to complete to assist with the park's assessment. Once completed, Guests will be given a list of attractions to safely enjoy.

### Ridership Criteria

The assessment of each attraction consists of the following criteria, which may be required to safely experience a certain attraction:

### ABILITY TO EXHIBIT INDEPENDENT SEATED POSTURAL CONTROL UNDER THE DYNAMIC CONDITIONS OF THE RIDE

 Explanation: Most rides require that riders have the body and spinal control to sit upright without the aid of other people or devices and be able to maintain proper riding posture, even during bumping or other characteristic movements of the ride.

### APPROPRIATE CENTER OF GRAVITY

o Explanation: Certain rides require that a rider's body has the appropriate weight distribution above/below the waist for that ride's restraint system.

### • CONTROL OF UPPER TORSO INCLUDING NECK AND HEAD

• Explanation: Most rides require riders to have sufficient muscle control to support their head, neck, and upper torso during the ride.

### ABILITY TO HOLD ON WITH UPPER EXTREMITIES

Explanation: Certain rides require that riders have either one, or both, functioning arms to hold on during the ride cycle. A functioning arm is an upper extremity or prosthesis exhibiting good grip control, the ability to brace, and the strength to allow the Guest to maintain the proper riding position throughout the duration of the ride.

### • ABILITY TO BRACE SELF WITH LOWER EXTREMITIES

 Explanation: Certain rides require riders to have one, or both, functioning legs to be used for bracing the body during the ride. A functioning leg is a lower extremity or a prosthesis that can be used for bracing.

### MINIMUM FUNCTIONING EXTREMITIES

Explanation: Certain rides require that riders have a minimum of one, two or three functioning extremities (two legs, two arms, one arm and one leg, etc.) to brace themselves during the ride.

## • ABILITY TO ENTER/EXIT THE RIDE WITHIN SPECIFIED PARAMETERS WITHOUT ENDANGERING SELF OR OTHERS

 Explanation: Guests must be able to enter and exit the ride without jeopardizing themselves or others, and to assist with their own evacuation if necessary. This may include arrangements such as entering through the exit or having someone in their party assist them in the boarding process. If a Guest must be lifted in and out of the ride unit, a responsible person who is accustomed to doing this must do so. Ride operators are not trained to lift or physically assist Guests.

# MENTAL CAPACITY TO BE AWARE OF HAZARDS TO SELF AND OTHERS; OR OF FAILURE TO RIDE IN PRESCRIBED MANNER

o Explanation: All rides require that riders have sufficient awareness to understand the consequences of actions that may lead to injury to self and/or others. Guests may be able to enjoy select rides when accompanied by a responsible person.

### **Basic Attraction Information**

- Every guest must have the ability to maintain the proper riding posture and brace themselves for any potential forces created by the ride and/or other participants
- o Guests with conditions such as pregnancy, back, neck or bone problems, cardiovascular problems, high blood pressure, recent surgery, or other health conditions that could be aggravated by select conditions should not ride all rides. All rides will have safety signs at the entrance advising of the conditions that a guest may have that should not participate in the attraction.
- o There is always a remote chance that a ride might be evacuated. Evacuations may be necessary due to a mechanical issue, weather, or power interruption. If an evacuation is required, you may be required to maneuver across catwalks, sometimes from the highest point on the ride. This may include walking down steeply inclined steps or waiting for an extended period of time in a ride vehicle. Our team members are not trained to lift or carry guests at any time.
- Any guest who experiences an attraction must be seated properly in the required riding position and have arms and legs inside the ride unit. All riders must use all safety devices as required in the normal operation of the attraction.
- o Any guest whose body dimensions prevent them from being safely secured in the attraction's safety restraint system will be unable to experience the attraction.
- A supervising companion is required for guests in certain height ranges or with certain physical conditions. A supervising companion must be over the age of 14 and meet all ride requirements to ride unassisted. On most rides, one supervising companion can accompany the number of riders that share a car, restraint, or row with each other.

### **Casts and Braces**

- Riders with casts that are braced (sling or other necessary additional holding component)
  or that extend past the elbow or knee may face restrictions on which attractions they can
  experience. Consult the individual attraction guides or visit Guest Services to receive a
  list of attractions that you may experience.
- Riders that have visible neck or back braces will not be able to participate in attractions that feature forces that could cause further injury. Rides that do not permit guests with these type braces will have that information in this guide and safety signage posted at each attraction.

 Braces need to be removed for Guests to be able to experience slide attractions in the SoakZone area. Riders with non-removable casts will not be able to experience water slides in the SoakZone area.

### Prosthetics and Residual/Missing Limbs

- On all attractions in the dry park, guests will be able to ride with any prosthetic device.
   Due to the nature of select attractions, prosthetics must be securely fastened so as not to come off unexpectedly during the ride cycle.
- Removable prosthetics must be removed before participating in waterpark attractions for the safety of our staff and guests. Guests with non-removable prosthetics cannot participate on water slides.
- o In the individual ride pages, each attraction has a specific guideline to the number of functioning extremities that a guest needs to be able to experience the attraction and any further stipulation on required residual limb length. Some attractions will require a guest be accompanied by a supervising companion regardless of height.

### Guests with Unique Body Dimensions

- The following attractions have a posted weight limit that will be checked by our staff.
   Only a red or green light will be displayed dependent on if the rider(s) meet the weight restrictions and all guests will be subject to this check.
  - o Rollo Coaster
    - o Maximum weight of 265lbs per row
  - o Pipeline Plunge
    - There is a weight limit for a single tube of 250lbs
    - There is a weight maximum for a double tube of 400lbs
      - There must be two (2) riders to ride in a double tube
- Other attractions in the park may have a maximum weight that is posted at the entrance of the attraction. It is up to the guests and their parties to verify their ability to meet those restrictions.
- All restraints need to be able to be secured properly for a guest to be able to experience an attraction. Guests with unique body dimensions may find difficulty with the following attractions:
  - Rollo Coaster
  - o Spider

### Strobe Lights and Magnetic Fields

Idlewild has limited attractions that utilize strobe lightning or that feature magnetic braking. Guests that are sensitive to strobe lights should be aware that Confusion Hill may use strobe lightning during special events (Hallowboo) and should check with a tour guide at the attraction before boarding. Wild Mouse, Tilt-a-Whirl, and Tea Party are the only attraction in the park that feature magnetic braking.

### Alternative Access Program (Boarding Passes)

We offer an alternative access program that, if you qualify, will allow you to use the accessible (ADA) entrance of the ride. The staff at Guest Services will ask you a series of questions to see if you qualify for this program. If you qualify you will receive a yellow Boarding Pass, allowing you access to the ADA entrance for the rides. The ADA entrance will be noted by a blue sign. In most, but not all, cases this is the exit of the ride.

Please wait until instructed by a Ride Operator to begin boarding. Our staff will accommodate riders using the alternative access point as quickly and safely as possible, while also being fair to the guests in the standard queue.

Please note: the Alternate Access Program is good for the individual that receives the Ride Admission Pass and three (3) additional guests. The individual with the pass must ride for the pass to be valid.

If granted admission into the Alternative Access Program, you will be able to initially board any one attraction with a minimal wait. After riding certain attractions one time, you will be required to get a boarding time equal to the wait time for that ride in the regular queue. You must wait until the given time to ride any other attraction that assigns return times. You can only have one boarding time at any given time. You cannot ride the same ride that requires a wait time twice in a row without receiving a wait time.

If we have stopped admitting Guests into the regular line for any reason, we will not admit Guests with an Accessibility Pass, either. This includes giving wait times or boarding with a time already assigned. Wait times must fall within regular park hours. You can ride any other attraction not listed below at any time.

Rides that assign wait times after riding: Rollo Coaster, Wild Mouse, Daniel Tiger's Neighborhood, Paul Bunyan's Loggin Toboggan, Ricky's Racers, Skooter, Spider

PLEASE NOTE: The Accessibility Pass is NOT a "front of the line" pass. It is designed for Guests who have a legitimate physical or mental condition that prohibits them from waiting in the regular queue. Guests caught abusing this program in any way, including falsifying information, transferring passes, or tampering passes are subject to have their Boarding Passes revoked and themselves removed from the park.

### Individual Attraction Information (Dry Park)

### **Adult Handcars**

### **Ride Description**

- Intensity: Mild
- The adult handcars are a unique guest powered attraction in which the guests have to crank the spindle on their vehicle to power their car around a flat track. The adult handcars allow for two riders per vehicle; one adult and one child

### **Alternative Access Point**

Ride Exit Gate

### **Boarding Time Required?**

• No

### **Height Restrictions**

- Driver must be at least 46 inches tall
- Passenger must be less than 46 inches tall

### **Ride Restrictions**

- Guests with the following conditions cannot ride:
  - Handheld Infants or Handheld Toddlers
    - Riders must be able to hold themselves upright unassisted to be able to ride
  - Braced Arm Cast
  - Full Leg Cast
  - Full Arm Cast
  - o Brace Between Legs
  - Cervical Collar, Halo, or Neck Brace
- Guests with the following conditions should not ride:
  - Recent Surgery or Illness
  - Heart Trouble
  - Pregnancy
  - High Blood Pressure
  - o Back, Neck or Bone Injuries

- Must be able to transfer into the ride vehicle
- Must have four (4) full functioning extremities (prosthetic or natural)
  - This can be overridden if a guest can display the ability to hold themselves upright in ride vehicle and successfully move the vehicle on their own
- Must have the appropriate center of gravity
- Must have the mental capacity to understand verbal instructions or be accompanied by a supervising companion

### **Balloon Race**

### **Ride Description**

- Intensity: Mild
- Eight gondolas shaped like hot-air balloons spin in a large circle while rising into the air. Riders have a sensation of soaring in a balloon on this mild family ride.

### **Alternative Access Point**

• Ride Exit Gate

### **Boarding Time Required?**

• No
